Additional safety inspection requirements for all motor vehicles and trailers, except semi-trailers, that have a MGW, as indicated on the vehicle registration certificate, over 10,000 pounds and under 18,001 pounds, except when the registrant requests a heavy vehicle inspection, may be found in section 79.23 of this Part.
